The WRC will consider whether the Town Plan is consistent with the Vermont Planning Goals, compatible with the Windham Regional Plan, compatible with the approved plans of other Towns in the region, and contains all the elements provided by the Vermont Planning and Development Act. The public hearing will also be held to consult with the Town of Athens and consider the confirmation of the Town's planning process as provided for by 24 V.S.A. § 4350(a). The WRC will hear all comments relevant to its review of the Town's Plan and planning process at the public hearing.
